Operation:

1. Install the LP-E6 battery onto the battery mount (6). Check the battery and charge if needed. Charging time for full charge is 2-3 hours.

2. Turn on the power switch (1). The OLED (3) will display the color temp and brightness as well as the battery level.

3. Press the Selection Lever/Push Switch(4) The > will allow you to select CCT or BRI. Once a selection is made, the setting can be changed by turning the same lever up or down.



4. Press the Mode button (2) once and the light will be in color mode. The hue can be changed using the Selection lever (4). To change the brightness, press the Selection lever/ push switch in until the > points to BRI. The brightness can now be changed with the Selection lever.



5. Press the Mode button(6) again and the light will be in Special Effects mode. Use the Selection lever to toggle through the 7 options. Press the Mode button again and the light returns to white mode.
